When It Happens

Mondays, starting January 2 (except 1/16 & 2/20)

Pioneer racers can ski and ride all day, and the Pioneer course is open from Noon - 4 PM.

Timed runs for adults begin at Noon, racers under 21 begin at 1 PM.

Registration Fees:

The cost for the entire season of Pioneer racing is just \$68 for an individual or \$756 for a team of 12 (\$63/person, paid with one check). King Pine season passholders are just \$50 each.

2012 Series Grand Prizes

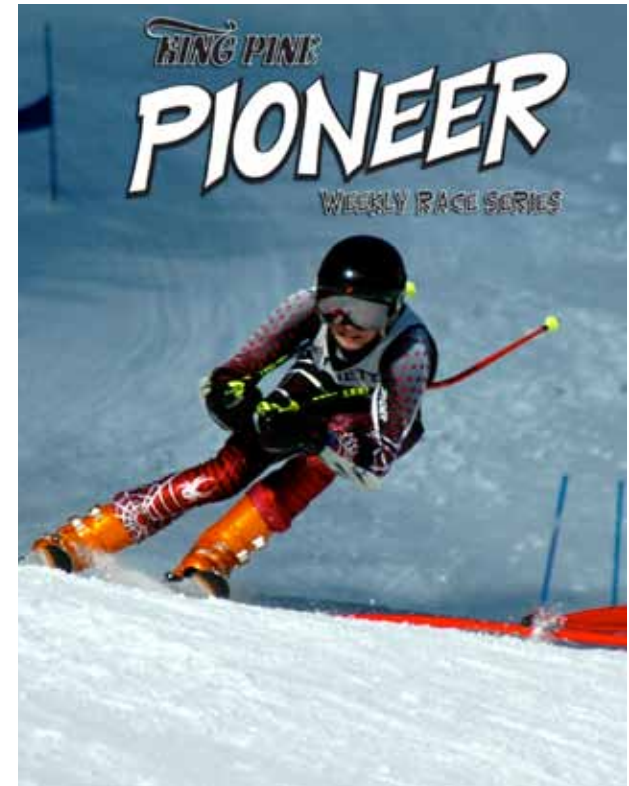
The 2012 winning team will be treated to a **party suite for 12 people** at the Verizon Wireless arena for a Manchester Monarchs AHL hockey game!
