CONDITIONS OF USE

I understand that this season pass is for my personal use only. It is not transferable. Season Pass privileges will be revoked for violation of this regulation. If my pass is lost, stolen, mutilated or otherwise deemed un-usable, I agree to contact guest services. **A fee of \$20 will be charged for replacement of a season pass.** Season passes must be prominently displayed and presented to the ticket checker each time I ride the lift. I agree that if I do not have my season pass, I will be expected to purchase a lift ticket at the regular price. Complimentary tickets will not be issued for lost or forgotten season passes. Management may revoke this Season Pass without refund anytime for misconduct or misuse. Attempting to access a lift with a Season Pass that is not valid on that day will result in a fee equal to a full-day lift ticket. Season Passes are non-refundable. _____ (initials)
