

Mini Hits is an informal "grass-roots" ski and snowboard contest for junior skiers and riders to be held in our terrain park and half pipe. Each competitor will pick his or her own trick and do it to the best of their ability. A panel of judges will assess each trick and prizes will be awarded accordingly.

The dates of the Mini Hits events will be 12/30/07, 1/27/08, 2/02/08, 2/23/08, and 3/1/08. One entry form will register a competitor for all six events. Registration will be at 12 - 1pm in the terrain park with practice from 12 - 1pm. The competition will start at 1pm and run until 2pm. Competitor under the age of 18 MUST have their parent or legal guardian sign the entry form and bring it with them to Compete.
