The *Sports Illustrated for Kids* Next Snow Search is a quest to find the neXtreme generation of skiers and riders. It's the first all mountain, all equipment, all person, style, attitude and personality snowsports competition for boys and girls 9-13.

The winner and one parent will be sent to Killington, Vermont to represent King Pine in the national finals, parts of which will be televised on NBC. Contestant must be 9-13 years old (born 1992-97) to compete. It's not just a competition; style, attitude and personality are also involved. There is only one class, everyone competes together. Boys and girls, skiers and riders and adaptive athletes are all included.

Each competitor will pick his or her own trick and do it to the best of their ability. A panel of judges will assess each trick and places will be awarded accordingly. One entry form will register a competitor for both qualifiers. Registration takes place from Noon to 1:00 PM in the terrain park, with practice also from Noon to 1:00 PM. The competition will start at 1:00 PM and runs until 2:00 PM. Competitors **MUST** have their parent or legal guardian sign the entry form and bring it with them to compete. 10-15 skiers or riders will qualify for the *Sports Illustrated for Kids* Next Snow Search King Pine Finals, scheduled for January 29, 2006.

Helmets are strongly recommended.
